### NOTICE OF ANNUAL TOWN BUDGET MEETING TOWN OF ELLINGTON

May 9, 2017

Electors and citizens qualified to vote in Town Meetings are hereby notified that the Annual Town Budget Meeting of the Town of Ellington will be held on Tuesday, May 9, 2017 at 8:00 p.m., prevailing time, at the Ellington High School, 37 Maple Street, Ellington, CT to consider the following:


To discuss and vote upon resolutions:

1. To approve the 5-year road reconstruction/overlay repair plan [pursuant to CGS Sec. 13a-99], as recommended by the Director of Public Works.
2. To accept prepaid grants and funds fully reimbursable for the Fiscal Year commencing on July 1, 2017 and ending on June 30, 2018, and to appropriate the same to the Board of Education in a sum estimated at \$2,430,455, as recommended by the Board of Education.
3. To determine that municipal tax shall be paid in two (2) installments for real estate and personal property tax in excess of six hundred (600) dollars and motor vehicle tax to be paid in one (1) installment with designated due dates as stated in the Connecticut State Statutes, Sections 12-142, 12-144, 12-144a and Public Act 77-343, Section 2 and to waive any property tax due in an amount less than five (5) dollars as stated in the Connecticut State Statutes, Section 12-144c, as recommended by the Tax and Revenue Collector.
4. To enter into a five-year lease agreement for the purchase of a Triple Combination Pumper for the Ellington Volunteer Fire Department not to exceed \$657,500.
5. To enter into a five-year lease agreement for the purchase of the Crystal Lake Fire Department Forestry Truck in an amount not to exceed \$200,000.
6. To enter into a five-year lease agreement for the purchase of the Crystal Lake Fire Department breathing apparatus equipment in an amount not to exceed \$190,000.
7. To enter into a five-year lease agreement for the purchase of the Ellington Volunteer Fire Department breathing apparatus equipment in an amount not to exceed \$500,000.
8. To adjourn the Annual Town Budget Meeting to a referendum to be held on Tuesday, May 16, 2017 from 6:00 a.m. to 8:00 p.m. with one question:

"SHALL THE TOWN OF ELLINGTON APPROPRIATE, AS RECOMMENDED AND AS ALLOCATED BY THE BOARD OF FINANCE, THE TOTAL SUM FOR ALL EXPENDITURES, A/K/A BUDGET GRAND TOTAL FOR THE FISCAL YEAR 2017-2018, \$57,110,601?"
