VERNON PUMP STATION UPGRADE

Sealed proposals will be received by the Town of Ellington WPCA, acting through its Finance Officer, to provide labor and material to upgrade the Vernon pump station.

Bid proposals for the Contract will be received at the Finance Department until **Wednesday, June 21, 2023, at 2:00 P.M.** Bids will then be publicly opened and read aloud in the Nicholas J. DiCorleto, Jr. Meeting Hall of Town Hall.

The Project includes the following Work:

The Project consists of the upgrade of the Town of Ellington's Vernon Wastewater Pump Station at 100 Windsorville Rd, Vernon, CT. The pump station upgrade includes 215 LF of ductile iron force main piping with associated trench and pavement restoration, bypass pumping during construction. Replacement of 3 dry pit submersible pumps and associated process piping, valves, piping supports. Upgrades to the HVAC, masonry re-pointing, roofing, wet well repairs, materials provided by owner, electrical improvements, instrumentation and controls, hazardous material remediation, and ancillary items.

To expedite material procurement, the Ellington Water Pollution Control Authority (WPCA) pre-purchased the following equipment: 1-Sluice Gate with ancillary equipment, 1-Generator set, automatic transfer switch with ancillary equipment and 3-Sewage Pumps, VFD s, and control cabinets with ancillary equipment.

Specifications and Contract Documents may be examined at the office of the Finance Officer, 55 Main Street, Ellington, Connecticut during normal business hours, on or after **May 10, 2023**.

Electronic Copies of the Contract Documents may be obtained at Project Dog (www.projectdog.com). Log in and enter the Project Code **855665** in the search box and select "Acquire Documents" for a free, downloadable bid set. Addenda, if issued, will be posted to the Projectdog website and shall be accompanied by e-mail notification to every individual or firm on record as having received the Bid Documents. It shall be the sole responsibility of the Contractor to ascertain the existence of any and all addenda. Hard copies of addenda will not be mailed or faxed. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office


A MANDATORY pre-bid meeting will be held with the Director of Public Works at **9:30 A.M., prevailing time, on Wednesday, May 24, 2023**, at the **Town of Ellington Vernon Pump Station, 100 Windsorville Rd, Vernon, CT 06066**. All potential bidders are required to attend in person. No bid will be accepted from an entity not attending the pre-bid meeting.

No bid may be withdrawn for a period of **ninety (90)** days after opening of bid without approval and written consent of the Town of Ellington WPCA.

The Town of Ellington WPCA reserves the right to amend or terminate this Invitation to Bid, to reject any or all bids, to waive any informalities, omissions, excess verbiage or technical defects in the bidding and the Town need not necessarily award the contract to the lowest Bidder if, in the opinion of the Town, it would be in the best interest of the Town of Ellington WPCA to accept another bid.
