**GENERAL REQUIREMENTS/SCOPE OF WORK**

**RESURFACING OF TENNIS & BASKETBALL  
COURTS**

The Town of Ellington, Department of Public Works is soliciting bids for the resurfacing of the existing tennis & basketball courts located at Tedford Park and the Ellington High School here in Ellington Connecticut.

The undersigned proposes to furnish all labor, material and services required to complete the work specified below in accordance with this document, and under the terms and conditions hereafter set forth and as directed by the Town.

1)      **CRITERA FOR BID ACCEPTANCE:**

Provide three recent reference projects, projects completed within the last 3 years.

Provide the required bid bond and insurance documents

Attend the mandatory pre-bid meeting

2)      **BASE BID:**

The bid shall be broken out as noted on the bid form.

3)      **\*The Riteway Crack repair is used as a reference only, equal to or a better crack repair material may be submitted and considered.**

The undersigned agrees to furnish and deliver said services according to the specification, at the price bid, as indicated, the resurfacing of the existing Tennis and Basketball courts shall be done in the following manner unless agreed upon and signed off on by the Director of Public Works. All Permits and approvals, if will be obtained by the Town of Ellington.

**TENNIS COURTS**

**ACCESS:**

Access to the courts will be accomplished via the existing gates for personnel and the equipment may be accessed by opening one side of the existing chain link fence upon approval by the Director of Public Works. Upon completion of the project the site will be returned to the condition that existed prior to the resurfacing and repairs and secured.

**SURFACE PREPARATION:**

The existing surfaces shall be thoroughly cleaned and free of all algae, mold, dirt and any other foreign material at Tedford Park, two (2) courts and Ellington High School, four (4) courts.

**CRACK REPAIRS:**

All cracks shall be repaired using the \*Riteway Crack Repair System and all shatter cracks should be repaired with a patch binder.

**TENNIS COURTS**

**SURFACE COLOR COATING:**

All courts will receive a two (2) coat acrylic coating surface system, a filler coat and a finish coat.

**LINE STRIPING:**

Layout and stripe all lines per USTA to 6 courts, apply acrylic primer and once cured apply one (1) coat of textured white line paint

**BID PRICE LINE STRIPING \$\_\_\_\_\_**

**LINE STRIPING 10 & UNDER AT TEDFORD PARK COURTS:**

Layout and stripe all lines for 10& under, two (2) courts at Tedford Park and apply one coat of acrylic line primer and once cured apply one (1) coat of textured white paint.

**PICKLEBALL STRIPING AT TEDFORD PARK COURTS:**

Layout and strip all lines per USAPA to the two (2) courts at Tedford Park and apply one coat of acrylic line primer and once cured apply one (1) coat of textured white paint.

**BASKETBALL COURTS**

**SURFACE CLEANING:**

The existing surfaces shall be thoroughly cleaned and free of all algae, mold, dirt and any other foreign material at Tedford Park two (2) basketball courts, one 90 X54 and the other 50 X 100

**COATING REMOVAL:**

Strip all coating from both courts, 9,900 square feet.

**COURT REPAIRS:**

Repairs to any sub-surface per square foot.

**CRACK REPAIRS:**

All cracks shall be repaired using the \*Riteway Crack Repair System and all shatter cracks should be repaired with a patch binder.

**COLOR COATING:**

Both basketball courts shall receive a three (3) coats of color, one (1) coat of resurfacer and two (2) coats of color.

Layout and strip all lines per NCAA, applying one coat of acrylic line primer and once cured apply one (1) coat of textured white paint.
